



European Professional Degree **Industrial Production Management :** **- Quality, Health, Safety, Environment-**

Who can apply

People with a Scientific, Economics or Law DEUG (the first 2 years of a BSc/BA Economics/Law course), with a technical DUT, a DEUST, BTS, European students having successfully completed the first 2 years of a BSc, or equivalent diplomas.

People from enterprises, administrations and Local Authorities with 2 successful years at university and whose professional experience has been validated... that wish to obtain a qualification and/or a technological and professional degree in the field of sustainable development.

Course content

The 360 hours of academic tuition have been organised into 10 Teaching Units (TU) of 36 hours each : 4 General Teaching Units (GTU) and 6 Professional Teaching Units (PTU). Each PTU has been divided into three 12 hour modules. Each main field (GTU and PTU) offers to the students multi-media training and "à la carte" training for people from enterprises. Each unit is organised into modules and the credits obtained can be accumulated.

GTU 1 : Destined to help the students to reach a standard level, according to their various origins.

GTU 2 : Communication in QHSE

GTU 3 : Development of awareness as regards Quality, Health, Safety and the protection of the Environment

GTU 4 : Knowledge of the enterprise, Law, Organisation, Economics

PTU 1 : Problematics and general methodology in Quality, Health, Safety , Environment

PTU 2 : Methods and technico-legal tools for quality at work

PTU 3 : Methods and technico-legal tools for the environment of the enterprise

PTU 4 : Methods and tools for the dependability of production systems

PTU 5 : Methods and tools for the quality of the processes and products

PTU 6 : Integrated Management system

A tutored project (130 hours)

A 14 week professional placement (equivalent to 490 hours) in an enterprise or a Local Authority

Initial training or continuous training through alternance.
